## **INSTRUCTIONS**

When a Bethel member desires to withdraw from the Order or desires to transfer her membership for any reason, the Guardian Secretary, by authority of the Executive Bethel Guardian Council, will issue to the Daughter a Demit on this form. It shall be completely filled in and signed by the Bethel Guardian and the Guardian Secretary under the Bethel seal. The member should be asked to sign the form.

If, within six months, the Daughter petitions another Bethel, the Demit (complete form) shall be attached to a Petition for Membership by Affiliation (Form 131). If the Daughter is elected to membership, the Guardian Secretary of the Bethel in which the Daughter is elected, shall complete the first, second, and third sections of the form and mail them to those designated. If the application is to another Bethel in the same State, Province or Country, or to a Bethel not under Grand Guardian Council Jurisdiction, the third section is unnecessary and may be destroyed. The fourth section shall be permanently attached to the Petition for Membership by Affiliation and retained in the Bethel files.
